Solar Panels

In 2022, following the commitment and the internal sustainability policy, we started the project for our own solar energy production. The initiative involved, through a specialized company (Latitude Solar), the acquisition of photovoltaic systems, the evaluation of the area for installation, an engineering project, the execution of the work and the approval of Companhia Paranaense de Energia – Copel. Partner Thiago Collodel, the head of the Infrastructure sector, reported that the project was completed in September 2022, which then allowed the office to generate renewable solar energy, providing sustainability and energy efficiency for all society.

Since the completion of the project, we have already produced 1.47 MWh, corresponding to the equivalent of 80.51 trees planted, 0.59 tons of coal saved and 0.85 tons of CO2 prevention released into the atmosphere, according to data from Solarman Smart.

Carbon Negative Seal

For the second consecutive year, we obtained the certification of Ecooar, an innovative platform for voluntary GHG compensation, with online public audit, due to our contribution to the protection of biodiversity, the protection of springs, the capture of Greenhouse Gases (GHG) and the environmental education through the preservation of forests and native species. The difference from the seal obtained in 2022 is due to the fact that our compensation, this time, was negative. "We offset CO2 in addition to the total amount emitted by the office at its headquarters and branches. There were 195 trees planted and 27,690 kg of CO2 retained from the environment", explains Rafaela Parra, the partner responsible for Marketing and Communication.


SocialPositive Women

Carbon market, a new commodity?



Rafaela Parra Environmental Law and ESG

The Paris Agreement, which is a global agreement on climate change, is the main instrument for promoting the carbon market, whith the purpose of defining a mechanism to reduce carbon emissions into the atmosphere, aiming at the reduction of local air pollution and of environmental degradation. The document sets a common goal of limiting the rise of Article 6 of the Paris Agreement, regulated during COP26, allows countries to share their efforts to achieve their climate goals through international cooperation mechanisms as well as carbon credit trading and technology transfer mechanisms.

In Brazil, the carbon market can have a significant and positive impact on agribusiness. This is because, in agribusiness, the topic of 'climate change' can be explored in different spectrums, while agro-industrial activity, especially within the gate, is closely related to the exploitation of natural resources.

To give space to the carbon market in agribusiness activities is to adapt to the future, because the business organizations of the future will be ethical, socially responsible and green, or they will not be. In this context, on the other hand, seeing the environment in an unromanticized way, but as a scarce asset, is the key point for the adoption of a disruptive and assertive green economy in its greater sustainability goals for present and future generations.

We are still facing a voluntary market. In 2021, Bill No. 528/2021, which aims to establish the Brazilian Emission Reduction Market, was submitted. The main idea of the bill is not yet to define mandatory targets for offsetting gas emissions, but to regulate the purchase and sale of carbon credits in the country.

Another recent legislation is Federal Decree No. 11,075/2022, whose purpose is to define procedures for the elaboration of Sectoral Plans for Mitigating Climate Change and to create the National System for Reducing Greenhouse Gas Emissions.

The "carbon" issue was also regulated by the CVM through the "Regulatory Framework for Sustainable Investment Funds", which is an important advance, including in relation to the Renovabio Legislation, but, in the field of "carbon credit", as we have seen, there are still many points to be improved.

But today it is no longer an illusion to think of carbon as a future commodity to be produced by Brazilian agribusiness and marketed globally, notably because it has a strong guarantee, such as the Brazilian production of grains, animal protein, sugar, citrus and coffee, for example. It is up to agribusiness, the State and the Brazilian people to foster and control this natural wealth.





Rodrigo Daher New Businesses

The purpose of this article is to expose the main reasons that led to the increase in M&A (Mergers & Acquisitions) operations in Brazilian agribusiness. Without any intention to deepen the technical issues of the operation.

The vast majority of mergers and acquisitions are carried out by technology companies, most of which are service companies that facilitate the routine, saving time and money of rural producers and agribusiness entrepreneurs.

M&A operations in the agricultural resale sector are also very heated, seeking a verticalization, the agrochemical industries themselves are in a movement of acquiring agricultural resales, in addition to those acquired by larger competitors, or by investment funds, which have increasingly been interested in the sector. These distributors are becoming an important financing player for production, due to barter operations for the acquisition of inputs.

A recent study published by KPMG showed that in 2022 there were 105.2% more M&A operations compared to 2021. In recent years, the advance of Brazilian agribusiness is evident, as it is breaking records of productivity, job creation and revenue. This is due to the evolution of the chain as a whole, there are several factors responsible for this advance that brings such positive numbers.

I highlight the following:

1. Worldwide increase in food demand:

The growing world population, the need to increase food production and the concern for the cultivation of food in a sustainable way, has attracted investments and opportunities for the sector, with business expansion throughout the production chain. It is important to remember that Brazil is the country with the greatest potential to meet this need in the coming years.

2. Technology:

Technology has been a key force in advancing agriculture, enabling farmers to increase efficiency and production. Thanks to technology, it was possible to increase production without increasing the planting area. Technology has enabled an area to produce "more with less". In addition, Brazil currently has more than 1,000 agtechs, which are technology companies focused on agribusiness that offer solutions within the entire production chain, from "before to after the gate".

3. Sustainability:

Growing concerns about environmental and social issues has led to an increase in the demand for sustainable solutions in agribusiness, including regenerative agriculture, organic food production and biodiversity conservation. Companies that lead the way in sustainability are often the target of acquisitions. An example is the accelerated growth of the use of bio-based materials, aiming at a cultivation that degrades the environment less and less, in accordance with a market that is increasingly selective and concerned with environmental and social issues.

Still with regard to sustainability, we can say that its role has an increasing impact on M&A operations, and it is important that companies consider some criteria when evaluating and communicating about sustainability.

There is a relevant risk assessment in the operation and ESG criteria are increasingly considered and included in M&A due diligence processes, with the purpose of identifying environmental, social and governance issues that may have an impact on the company's value. In addition to the value that can be affected, care is needed when communicating with stakeholders. ESG issues have become increasingly important to investors, customers and suppliers, and need to be considered in communication strategies during and after an M&A.

It is important to note that, despite the strength of the sector, both buyers and sellers are motivated by objective criteria when they choose to acquire or sell a company.

From the buyer's side, I highlight:

- a. Growth: the acquisition of another company can allow the buyer to expand their customer base, increase their market share, and gain access to new markets or technologies.
- b. Synergies: the buyer can seek synergies, such as combining operations, eliminating redundancies and achieving economies of
- c. Diversification: the acquisition may allow the buyer to diversify its business base while minimizing the risk associated with a single sector or market.
- d. Access to resources: the acquisition can enable the buyer to acquire important resources such as brands, assets, and technologies.

From the seller:

- a. Liquidity: selling a company can provide the seller with a strategic exit and a source of funds for other investments or projects.
- b. Valuation: the seller can aim to maximize the value of their company by selling it, taking advantage of the demand of buyers interested in the company or sector.
- c. Competition: the seller may aim to avoid future competition from another d. company or a potentially hostile buyer.
- e. Succession: when there is no natural successor prepared to take over the management of the company, so as not to end the operation, one can opt for the sale.

With the advancement of Brazilian agribusiness, due to world demand and Brazil's ability to be the main country to meet this need, the trend is for an increasing interest in companies in the sector. and consequently, an increase in M&A operations in agribusiness.

Once Brazil's presidential elections in 2022 are defined and the Federal Government's transition team is installed (Law No. 10,609/2002), it is necessary to make a brief reflection on the tax perspectives for the year of 2023.

One of the most relevant issues to be faced by the elected Government will undoubtedly be the Tax Reform, which has been underway in the National Congress since 2019, without much significant progress.

In fact, there are two Constitutional Amendment Proposals: (1) PEC 45/2019, initiated by Deputy Baleia Rossi (MDB/SP), based on the study developed by Economist Bernard Appy, and; (2) PEC 110/2019, which, although collectively proposed by the Senate, is led by Senator Davi Alcolumbre (DEM/AP), being a reproduction of the proposal presented by Deputy Luiz Carlos Hauly, author of PEC 293/2004.

It is noteworthy, moreover, that Araúz Advogados promoted an event on 02/06/2020 to discuss with the creators of the aforementioned PECs about the effects of the Tax Reform for Agribusiness, with the presence of former Minister Roberto Rodrigues.

Currently, the fact that the creator of PEC 45/2019, the Economist Bernard Appy, has been appointed to hold the position of Extraordinary Secretary of Tax Reform of the Ministry of Finance is very

relevant. Therefore, there is a high probability that its guidelines will be even more prominent among the parliamentarians who will examine the proposals for Tax Reform.

Through PEC 45/2019, there will be the creation, by Supplementary Law, of the Tax on Goods and Services - IBS to replace IPI, PIS, COFINS, ICMS and ISSON. The IBS shall be non-cumulative, generating credits for offsetting debts, in the various circulation operations of the production chain, focusing on all goods and services, including the exploitation of tangible and intangible goods and rights, and the leasing of goods, in domestic market and import operations, except export operations. The rates will be uniform in each federative entity, and may differ per unit, provided that it is applicable in the same way to all goods and services consumed therein. These rates will be defined by the law of each federative entity.

The distribution of tax revenues for each federative entity will be defined from "sub rates" and the transition to full implementation will take ten years.

However, PEC 45/2019 does not allow the granting of tax benefits or special regimes, which, in addition to other discussion points, should be the aspect that will impact the most on Brazilian Agribusiness.

This is because the food and commodity production chain has several tax incentives and benefits, such as presumed ICMS, PIS and COFINS credits, which are absolutely necessary to neutralize the effects of cumulative taxation. Otherwise, there is cascade taxation, an effect that burdens the final consumer.

It is worth noting that Brazilian Agribusiness is driven, for the most part, by the small individual rural producer who carries out its activity under a family economy regime, and the acquisition of its production does not generate PIS and COFINS credits for the acquiring agribusiness. Therefore, agribusinesses bear the cumulative effect of taxation, increasing the cost of production, except in acquisitions of legal entities, which weakens the small producer. That is why Article 8 of Law No. 10,925/2004 grants "presumed credits" of PIS and COFINS, allowing the effects of cascade taxation to be annulled in this production chain.

In addition to this, there are other tax benefits and similar special regimes, which aim to strengthen the chain as a whole, contributing so that the small rural producer can carry out its activity and commercialize its production, generating income and wealth for the countryside, allowing Brazilian Agribusiness to produce competitive and quality food, increasing jobs and collection, bringing affordable products to the national and foreign final consumer, ensuring food security with sustainability.

In this scenario, the Tax Reform must consider the social and economic vocation of the country, so that there is a strengthening of the productive sector, including Agribusiness, so that there is sustainable development.

On the other hand, the year of 2023 reserves the expectation that several decisions will be made regarding tax issues relevant to Agribusiness.

This is the case of the responsibility of the purchaser for the retention of Funrural in the acquisitions of rural production of an individual producer. Although in 2017 Funrural was adjudicated as constitutional since the publication of Law No. 10,256/2001, at the end of 2022 the STF understood the unconstitutionality of the acquirer withholding the contribution of the individual's rural production.

However, in 2023 the STF must analyze the validity of this decision on withholding, since the vote of retired Minister Marco Aurélio would have been cast without going into the merits of the matter. Thus, there is the possibility that another Minister will have to speak, which may change the result of the 2022 decision, considering that the vote was 6x5 due to the unconstitutionality of the withholding obligation by the acquirer.

Any change will have a significant impact on agribusinesses, due to the administrative and judicial discussion about the launches of Funrural, made based on the obligation to withhold the contribution by the acquirer and its responsibility for the collection of amounts that were not discounted from producers.

The evolution of Business Law

In my law degree, in the early 2000s, we studied Commercial Law as an autonomous subject, which addressed the figure of the merchant, the obligations that were common to them, credit securities, bankruptcy, among other topics, relevant to acts of merchandise.

The Brazilian Commercial Code (Federal Law 556/1850) dealt with acts of merchandise, defined by regulatory norm (Federal Decree 737/1850), which was interpreted extensively by the national doctrine and jurisprudence, to cover the new forms of exploitation of economic activity.

Over time, the concept of a company went beyond merely commercial activities and the typical act of commerce, evolving into a "Business Law" that focuses on the figure of the entrepreneur, the one who exercises economic activities, to whom the

Federal Constitution grants freedom, regardless of authorization from public entities. The 2002 Civil Code revoked articles of the Commercial Code and established the Business Law, naming as an entrepreneur "those who professionally exercise economic activities organized for the production or circulation of goods or services (art. 966).

Business Law was also complemented by sparse rules to reduce bureaucracy for small economic agents and individual companies, reinforcing free initiative and the free exercise of economic activity by the very recent Federal Law 13,874/2019.

The range of action of Business Law is not limited to the opening of companies, merger of companies, dissolution of companies and recovery of companies that are going through financial crises, nor to contracts and commercial relations. The business performance

involves particularities that demand different specialties of law, especially because companies face challenges of all kinds, from logistical difficulties to fiscal, contractual and insurance costs, and even the prevention and repair of civil and consumer damages.

Logistics difficulties arise from several factors, such as the absence of infrastructure in the most different modalities; predominance of road transport at the expense of rail and waterway transport; precarious conditions and lack of road safety; limited extension of the railway network throughout the national territory; lack of port and waterway infrastructure, in addition to dredging problems and precarious land access to waterway transport. The need for investments in infrastructure is evident, either to improve the operation of each of the modalities, or to implement the appropriate connection between them, ensuring the adequate flow of products that circulate internally and for export purposes.

The labor, environmental and regulatory challenges derive from the adequate administrative and judicial interpretation of the current rules, and many of them are sparse and of an infralegal nature, even leading to the need to amend the Law of Introduction to Brazilian Law, which from Federal Law 13,655/2018 established that the administrative, controlling and judicial spheres must not decide based on abstract values and must consider the practical consequences of their decisions. There is also no lack of tax constraints, considering the high tax burden, the constant legislative amendnets and the new interpretations given by the Courts.

Business Law must, therefore, be seen in a broad sense, under a multidisciplinary view, which passes in a relevant way through the incorporation of companies (Corporate Law), but goes hand in hand with other branches of law, such as Labor Law, which will regulate the relationship between entrepreneurs and their employees; Tax Law, regarding the company's tax obligations and tax planning; Environmental Law, regarding respect for the sustainable and balanced environment; Administrative and Regulatory Law, regarding compliance with sanitary, logistical and customs rules, in addition to specific rules for activities subject to regulatory agencies, such as health operators, concessionaires providing public services; among other areas, not less important, such as Civil Liability, Consumerist; Contractual, Bankruptcy and Reorganization, Credit Recovery, Intellectual Property, Corporate Governance, Arbitration and International Law for relations that affect the national territory.

The challenge of the practice of business law is precisely to find the link between all these autonomous areas of law in favor of the business activity developed by clients, connecting businesses, partners and opportunities. And it is not a question of being a generalist lawyer, but rather of being an expert lawyer, who is able to understand the client's need and the link between the different branches of law, in the search for related solutions, aiming at economic, social, sustainable growth, as well as the perpetuity and longevity of companies.

How do you see the future changes in the financial market in the face of globalization and the political future in the country?

A: I strongly believe in cooperativism as an alternative in the financial market, being a junction of the economic and the social. We are going through many changes between the traditional and the digital financial system: this intermediate option offered by cooperativism strengthens the local economy, which is preponderant for the generation of unemployment and income, improving people's quality of life. Cooperatives are "prosumer" companies, that is, they produce what they consume. We live in societies of savers and credit-taking people/companies. The associates themselves form the financial reserves, resulting in funding for the investment in the associates' own activities. We can say that it is a modern business model and an excellent alternative in the financial market. I also understand that the future of Brazil depends on all Brazilians who work in agriculture, businesspeople, entrepreneurs, workers, service providers and the organized entities that make the economy happen. It is up to the federal, state and municipal governments to be facilitators, and not to hinder. In this way, the Brazilian economy will be strengthened.

What is the role of credit unions in the agricultural supply chain?

A: Most credit unions in the Sicredi System originated in rural areas, in partnership with agricultural cooperatives. The opening of cooperatives to the urban environment allowed greater leverage of resources and made cooperatives play a key role in the agribusiness sector. Currently the Sicredi System is the second institution in volume of rural credit resources. The proximity to the agribusiness public and understanding the needs of rural producers to better serve makes cooperatives have a very important role in the supply of credit for the costing and investment in agribusiness.

What is your opinion on the confrontation, by Brazilian agribusiness, of current challenges, such as climate change and the volatility of input prices?

A: I understand that this has been the great challenge and at this point the focus on sustainability has to be a priority, with the development of technologies that add to the economic, social and environmental areas. We have our sustainability policy in the cooperative and in the Sicredi system, and this has provided us the leverage of external resources to increase technology, with cost reduction, and to finance the diversification of rural activities, improving the income of the agricultural sector.

For 2023, are you optimistic that agribusiness will reach new markets, trade partnerships and good economic performance?

A: We are always optimistic about agribusiness. Brazil has a vocation to produce food for the world and we are increasingly adding value to rural products, such as transforming soybeans and corn into animal protein. This movement has to be more publicized and understood by society. With agribusiness producing and adding value, we will be contributing to the construction of a more prosperous society. Each Real (BRL) invested in the diversification of rural activity generates a wealth of 2.45 reais – an income that is kept for the improvement of price and income for the producer, generates jobs in the countryside and in the industry, trade and service sectors, strengthening the society as a whole. Sicredi is focused on this business model, promoting local development. We also think that this is how we will make an increasingly strong economy. Starting in the small community and becoming attractive to people from the big urban regions, they are returning to the interior of the country, attracted by the employment opportunities and quality of life. We are already observing this movement in many regions of Brazil and this is the path to economic development.

How do you evaluate the impact of the fiscal and monetary policy of the elected government, given the rumors of the measures to be adopted?

Since being elected, the government has highlighted that it will bring policies of higher spending, and this is a concern, as we know that the reality of the Brazilian public apparatus cannot include any more expenditures. With no signs of fiscal austerity and responsibility over the spending ceiling, medium-term interest rates have sharp rises, culminating in economic contraction. We remain attentive to the new fiscal framework and how the government will address the need for policies that do not point to increased inflation, but rather to control and economic growth.

What is your opinion on what will be the economic situation in Brazil for 2023? Do you believe that the scenario of high interest rates will continue?

Yes, we should have higher interest rates for longer, considering the expansionist policy of the government, which values spending, and not reformist measures. Taking into account that we already have interest rates at very high levels, there are no expectations of higher highs for 2023; however, we hope that inflation begins to decrease, which could give us signs of a low Selic. As we have seen, the credit market has charged even more expensive rates for the financing of companies, in view of the current scenario, a fact that delays the economic development of the country.

For you, what is the ripple effect in relation to the devaluation of the Real against the dollar in the financial market and in the capital market?

If we look at the performance of the exchange rate in the last 24 months, the Real has devalued little in the period – despite the oscillations. However, the fact that we have the highest real interest rate in the world contributes to the Real not depreciating so much against the American currency. If we continue with prospects of economic deterioration, surely our currency will suffer against the dollar in the medium term.

Considering the protection of assets, do you believe that it is time to invest in dollars? How can Brazilians do this effectively?

At Nord, we continue to recommend that people have part of their equity in dollars and we see the level of R\$5.00 attractive for the purchase of dollarized assets. There are several ways to do this, from buying funds that replicate American assets at Brazilian brokers to ways to send dollar remittances for investment directly abroad. Nord customers with values from 300 thousand USD have access to the offshore structure, which has tax benefits and successions with regard to investments abroad. I reinforce that, more than setting the exchange rate, it is important to create savings in dollar and to protect the equity accumulated during a lifetime.

How does your profession enable investors to plan and protect their assets for years to come?


